INSTRUCTIONS FOR NAME CHANGES
CONFIDENTIAL RECORD**

All forms must be typed or clearly printed in ink. The Court will not accept forms for filing unless they are accurate, complete, and legible. If you have legal questions about this procedure or are unable to properly complete the following forms, please seek assistance from a qualified attorney. This packet should only be used if you can demonstrate good cause not to publish notice of your name change proceedings. All other name change requests should be processed using Form PC51. Laws and rules regarding name changes are found at MCL 711.1 to 711.3, and in MCR 3.613.

CHECKLIST FOR PETITIONER

- [] Applicant has been a resident of Saginaw County for a minimum of 12 months immediately preceding the filing of the petition.
- [] The **Petition to Change Name** (PC51c) is completed and signed.
- [] An **Addendum to Protected Personal Identifying Information** (MC97a) is completed with the name and date of birth for each individual whose name is being changed.
- [] Proposed **Order Regarding Ex Parte Request for Nonpublication and Confidential Record** (PC161) is completed.
- [] Applicant is required to disclose any **criminal history**. If a criminal history is indicated, a copy of the relevant criminal record must be attached to the petition prior to filing.
- [] **Filing Fee** - \$187.00 payable to the *Saginaw County Circuit Court*. The filing fee includes the cost of one certified copy.
- [] **Additional Certified Copy of Order to Change Name (Optional)** - \$12.00 per copy, payable to *Saginaw County Clerk*.

ADDITIONAL CHECKLIST FOR MINORS

- [] **Minor's Consent to Name Change** – If the minor is 14 years or older at the time of the hearing, they **must** sign the Petition or submit a Minor's Consent to Name Change (PC51b). If the minor is under the age of 14 and able to state a preference, they should sign the Petition.
- [] **Non-Custodial Parent** - If the non-custodial parent of a minor for whom name change is sought has not signed the Petition, a hearing will be required. If the address of the non-custodial parent:
 - is **known**, then along with your Petition, a Proof of Service (PC564) indicating that a copy of the Petition for Name Change and Notice of Hearing was provided to the non-custodial parent.
 - is **not known**, and cannot be ascertained after diligent inquiry:
 - [] Declaration of Intent to Give Notice by Publication (PC617).
 - [] Publication of Notice of Hearing Regarding Petition for Name Change (Noncustodial Parent), Form PC50c. **Additional publication fees will be incurred.**
- [] **Child Support Payment History** – If both parents have not signed the Petition and the custodial parent filing the Petition claims that a support order has been entered and the non-custodial parent has failed to substantially comply with the support order for a period of two years or more before the filing of the Petition, then a **Child Support Payment History must be obtained from the Friend of the Court and filed along with the Petition.**

- [] **Criminal Conviction of Non-Custodial Parent** – If you allege under paragraph 10(b) on the Petition that the non-custodial parent has been convicted of child abuse (MCL 750.136b), criminal sexual conduct (MCL 750.520b, 750.520c, 750.520d or 750.520e) or assault with intent to commit criminal sexual conduct (MCL 750.520g) and the minor(s) or a sibling of the minor(s) was the victim, you **MUST ATTACH JUDGMENT OF SENTENCE**. If you allege under paragraph 10(c) on the Petition that the non-custodial parent has been convicted of first degree murder (MCL 750.316) or second degree murder (MCL 750.317), you **MUST ATTACH JUDGMENT OF SENTENCE**.

GENERAL INFORMATION ABOUT CONFIDENTIAL NAME CHANGES

Hearings: A hearing will be required if the request is for a minor and both parents have not consented to the name change or if a significant criminal history is disclosed or revealed following a criminal history background check. Hearings are generally scheduled at 1:30pm on Wednesday.

Criminal History Report: The petitioner may use ICHAT to conduct their background check and attach a copy to the petition prior to filing.

Publication to Noncustodial Parent (if required): If publication to the noncustodial parent is required, it is the Petitioner's responsibility, once a hearing date has been provided to submit the Publication of Notice of Hearing to a newspaper as defined by MCR 2.106(F) for publication in Saginaw County. The Publication of Notice of Hearing should be immediately submitted to the publication of your choice and arrangements made for payment. A copy of the Affidavit of Publication must be received a minimum of 14 days prior to your scheduled hearing. Failure to timely pay the publication fee may result in cancellation or adjournment of your hearing.

For your convenience, contact information for a commonly used Saginaw County publication is provided; however, you may utilize any newspaper meeting the requirements under MCR 2.106(F).

Additional Certified Copies: One certified copy of the Order Following Hearing on Petition to Change Name will be provided to the petitioner. Additional certified copies may be requested in person at the Saginaw County Circuit Court Clerk's office, 111 S. Michigan Ave. Saginaw, MI 48602, or via mail. If an Order has been entered granting the request for nonpublication and confidential record, ID will be required, and copies may only be released to those individuals entitled to a copy by law.

Obtaining a New Birth Certificate: If you were born in Michigan and wish to obtain a new birth certificate from the Michigan Vital Records department showing the new name, you must file an [Application to Correct or Change a Michigan Birth Record](#), (form DCH-0847). The current fee to obtain an amended birth certificate is \$50.00, payable to the State of Michigan. You will be required to send a certified copy of your Order along with the completed form and fee. If you were not born in Michigan, you will need to consult the specific requirements of the state in which you were born.
